# **ELECTRICAL REQUIREMENTS FOR SPAS**

- 1.3 WIRE + GROUND (2 HOT, 1 NEUTRAL, 1 GROUND). WIRE SIZE DEPENDS ON BREAKER SIZE AND DISTANCE.
- 2. DI SPAS: 110V TUBS, 15 AMP GFCI'D CORD PROVIDED (15' TOTAL LENGTH). 220V TUBS, 1 JET PUMP: 30 OR 40 AMP GFCI'D BREAKER. 2 JET PUMPS: 30, 40 OR 50 AMP GFCI'D BREAKER (SUPPLIED BY ELECTRICIAN). SEE ARCHITECTURAL DRAWING PDF ON WEB SITE PAGE OF YOUR TUB MODEL FOR SPECIFIC DETAILS. IN GENERAL, CODE REQUIRES THE DISCONNECT SHOULD BE LOCATED WITHIN 50' LINE OF SITE AND NO CLOSER THAN 5' FROM THE INNER WALL OF THE HOT TUB. CHECK WITH YOUR ELECTRICIAN FOR EXACT DISTANCE.
- 3. WIRES SHOULD BE IN PROTECTED 1" CONDUIT. FOR DI SPAS, ONCE THE CONDUIT HAS REACHED THE HOT TUB, THERE IS A 1" FEMALE FITTING TO ACCEPT THE 1" MALE RIGID CONDUIT. A CHASE WAY IS PROVIDED INSIDE THE TUB FROM THERE THAT LEADS RIGHT TO THE TERMINAL BLOCK OF THE HOT TUB EQUIPMENT PACK. OTHER BRANDS YOU HAVE TO CONTINUE THE CONDUIT INSIDE THE TUB UNTIL YOU REACH THE EQUIPMENT PACK.
- 4. DI SPAS TIP: THE USE OF AN LB FITTING AT THE ENTRANCE TO THE TUB WORKS WELL.
- 5. THE DISPAS.COM WEB SITE HAS LINE DIAGRAMS FOR THE EXACT LOCATION OF ELECTRICAL LOCATIONS FOR EVERY MODEL. GO TO YOUR MODEL AND DOWNLOAD THE ARCHITECTURAL DRAWING PDF FILE ON THE RIGHT SIDE OF THE PAGE.
- 6. FOR ALL 110V CAPABLE SPAS: JOURNEY, SERENADE AND COVE. THESE MODELS CAN BE SET UP FOR EITHER 110V OR 220V. ONLY THE JOURNEY COMES STANDARD AT 110V W/A 15' GFCI'D CORD. THE SERENADE AND COVE: A 15' GFCI'D 110V CORD WILL BE PROVIDED BY US IF YOU ARE GOING TO SET UP YOUR TUB FOR 110V. 15A BREAKER. FOR ALL 110V/220V TUBS, WE NEED TO KNOW AHEAD OF TIME HOW YOU WILL BE WIRING IT.
- 7. ALL HOT TUBS MUST BE ON A DEDICATED CIRCUIT. MEANING, NO OTHER DEVICE CAN BE USED ON THE SAME BREAKER.
